Purpose of consultancy:	The national reproductive health programme has contributed to impressive achievements that the Maldivians are enjoying at present. The population growth rate has reduced to 1.65 with the total fertility rate just at replacement levels. At the same time, unmet need for family planning is high when compared to the health achievements made recently. Emerging health issues such as increasing reproductive health and non-communicable conditions such as Polycystic Ovarian Syndrome (PCOS), endometriosis and infertility are common among the reproductive age groups. On the other hand, unwanted pregnancies are prevalent especially among drug users.
	The Maldives demographic situation is at an interesting crossroad where the young people still dominate the bulk of the population and the country is projecting an ageing population in the near future. Other demographic indicators such as high international migration, especially men, to cater to the economic sectors including tourism, construction and fishing places the society at a unique position with the sex ratio of the labourforce at 208.
	Against this backdrop, UNFPA is keen to have a deeper understanding on the drivers of low fertility to have a better understanding of the dilemma around low fertility, low CPR and low growth rate in the Maldives. The emanating suggestions attribute to current lifestyles and morbidities as well as the arrangement of the economic sector in Maldives.
	Hence, UNFPA is seeking an international consultant to assist the country team in carrying out a qualitative and or mixed method research that will systematically examine the drivers of low fertility in Maldives.

(Description of services, activities, or outputs)	 The Consultant is expected to work closely with the Maldives National University to carry out the Desk review of relevant national policies and regulations related to low fertility and other available documents, including survey and research reports, guidelines on family planning programme of Maldives; Review existing methodologies and consult with stakeholders across different sectors and levels to develop a suitable methodology to capture the ideation, determinants, drivers, postponement of childbearing, accessibility of services, economic and other constraints With support from the Maldives National University, develop tools and train the field work team to conduct the data collection Support the Maldives National University to transcribe and analyze the findings Develop the report to capturing findings and recommendations to guide relevant policy changes
